Mary Jane Rises

I t was the passing of her mother almost two years ago that was the pivotable moment for Mary Jane, or "Jane" as she prefers to be called. Her mother had never turned her back on her during 35 years of actively using crack cocaine and alcohol. Jane always had a place to go, a roof over her head, food to eat, and money to support her habit. But now her mother was gone.

Jane left Philadelphia, the only city she had ever lived in, and arrived in Hartford in May of 2020. After completing a local detox program, she arrived at the Women's Recovery Program at Mercy Housing's St. Elizabeth House. She had never been clean for a month at this point. She struggled in the beginning. She didn't know how to surrender what she was used to doing for all of those years.

But she knew that she wanted and, more importantly, needed help.

As she worked through the program, Jane never felt alone. She credits her case manager, Serlena, for keeping her on track and for believing in her. "The staff at Mercy Housing saw something in me that I didn't see in myself."

"This was the best decision I've made in my life," she said. Last June she celebrated one year in recovery with a large picnic attended by family and friends. People traveled from Philly to be there with her. It was at this celebration that Jane's daughter forgave her. In Jane's words: "My daughter, my only child, went through the addiction with me. Her forgiveness of me were the sweetest words that a mother could ever hear."

Jane currently holds a 91 average in a GED class that Mercy staff encouraged her to take. She will graduate in May as a certified nursing assistant, and currently works at Hartford Hospital part-time. She holds a lease to her own apartment in Vernon and has her own car. In her spare time, she organizes donated clothing at Mercy Housing and runs a women's group she calls "I Rise". She says, "People, especially women, who are struggling with addiction have had their heads down for so long. We need to lift our heads, look at ourselves and start loving who we are." Additionally, she wants people "to not look back, but focus on the future. There is always hope. Believe in yourself."

Jane wishes her mother could see her now.

Friendship Center Receives \$100,000

During a time of increased food insecurity, Mercy Housing's
Friendship Center received a donation of \$100,000 from Navigate Affordable Housing Partners. "This couldn't have come at a better time," said Kara Capone, CEO of Community Housing Advocates, the umbrella organization to Mercy Housing and Shelter. "Between COVID-related expenses and the rising costs of food, this generous donation will allow us to continue to meet the critical needs of our community."

One of only two day-shelters in Hartford, the Friendship Center offers services when many traditional shelters are closed. Patrons can take advantage of shower and comfort facilities, a food pantry, access health screenings provided by graduate nursing student interns, as well as receive assistance accessing programs to meet their needs such as benefits, housing programs, behavioral health and substance abuse treatment, all through the outreach case manager. The Friendship Center also provides thousands of meals annually via its breakfast and lunch service provided Tuesday through Saturday.

Lisa McCarroll, CEO of Navigate Affordable Housing Partners, said: "Our goal with the Navigate Gives Back grants is to help like-minded organizations fulfill their missions. Mercy Housing and Shelter Corporation's commitment to eliminating homelessness aligns with our belief that everyone deserves safe, affordable, and quality housing. We appreciate everything you do for the community."

Navigate Affordable Housing Partners is a nonprofit that actively works to enhance all aspects of the housing industry to ensure that people have access to quality, livable housing choices. They are headquartered in Alabama with offices in Mississippi, Virginia, and Connecticut.

Board of Director, Elisabeth "Lisa" Hoisl, is a Vice President at Travelers and knew her

company was donating meals to local organizations while their employee cafeterias were closed. Lisa explained the dilemma at St. Elizabeth House and secured 125 prepared meals, five days a week, for the months of January and February.
