

YOUR STEWARDSHIP IN ACTION

Your support makes a difference in the lives of the individuals and families Mercy Housing and Shelter Corporation serves. Here are some of the ways you helped during the 2023 fiscal year:



81,029 meals were served between St. Elizabeth House and the Friendship Center.



149 households were served by our Permanent Supportive Housing program, which helps those with very low incomes and serious and persistent conditions have a place to call home.



151 households were served by our Rapid Rehousing program, which helped them find and maintain housing after experiencing literal homelessness.



199 individuals with complex needs were assisted on their road to recovery and housed through our residential programs.



Mercy Homeless Diversion staff kept **947 participants** in a housing crisis out of a homeless shelter:

- **735 participants in Greater Hartford** were served in partnership with the Greater Hartford Coordinated Access Network.
- **212 participants in Greater Middletown** were served in partnership with the Middletown-Meriden-Wallingford Coordinated Access Network.

Other Accomplishments:

• The Haven at Charter Oak celebrated its first anniversary as a program in 2023.

SISTER PAT IMPACTS MERCY HOUSING

Sister Patricia "Pat" McKeon, RSM, is many things: a member of the Sisters of Mercy, a former Executive Director of Mercy Housing and Shelter Corporation, and a staunch advocate for the hungry and homeless in Hartford. Sitting down with her is more than an opportunity to learn about her time at Mercy Housing – it is a window into how the state of homelessness has changed since the Sisters of Mercy took on housing as a corporate ministry in 1983.

"Homelessness as we know it today was just coming to the fore," she says, identifying the closure of Connecticut's psychiatric hospitals as a flashpoint in the rise in homelessness in Greater Hartford. "I know people came to us and said, 'Well, their discharge plan was to go to the soup kitchen, go to the shelter, and go to Welfare on Monday'. And, often, this was Friday afternoon."

The AIDS crisis of the 1980s and 1990s demonstrated how multifaceted the issue of homelessness can be. The public health risks and ostracization of those living with HIV/AIDS was a detriment to their wellbeing. Mercy Housing addressed this by opening Mercy House; Connecticut's first 24/7 program for single, homeless adults living with HIV/AIDS and co-occurring disorders. Sister Pat mentioned the broader purpose of Mercy House, beyond managing a participant's illness. "We made them feel safe. We made them feel loved."

Ensuring those experiencing homelessness could be housed was a large part of Sister Pat's tenure as Executive Director. Between 1998 and 2015, Mercy Housing expanded its Permanent Supportive Housing initiatives, opened The Residence at Saint Mary's and Catherine's Place, and made significant capital improvements to St. Elizabeth House. She also implemented the Recovery model of care agencywide, which empowers participants to move towards self-sufficiency.

When asked why supporting Mercy Housing and Shelter Corporation is so important, Sister Pat provided a simple answer. "It's being a good person...to be able to relate to another person in need."



Income By Source \$








